a. 7: 05 p.m. – Municipal Waste Management

Municipal Waste Management President, Logan Baniulis and Manager Tim Oliver attended the meeting to discuss proposed upgrades to the current Landfill site located at 35-8-21W. An application has been prepared for Manitoba Conservation and Water Stewardship for approval of a proposed licensed soil treatment facility. This site would be for the treatment and disposal of petroleum contaminated soil (PCS). The municipality will be provided information and opportunity for comment through the application approval process by the provincial department. Mr. Baniulis also advised council that their recycling and waste collection program is increasing and may in the future consider a recycling facility at the site in Souris-Glenwood. The delegation was thanked for attending the meeting.

b. 7:30 p.m. Emergency Measures – Coordinator – Bruce Apperley

Mr. Bruce Apperley, Souris-Glenwood Emergency Coordinator, attended the meeting to update on the current emergency plan. Mr. Apperley advised that the generator system that was installed at the Fire Hall is operating and has been utilized during recent power outages. Bruce will be attending the Manitoba Emergency Management Course. Other discussions included implementation of an early warning system for emergency weather events. Council thanked Mr. Apperley for attending the meeting.
