- a) Tender – Plum Creek Bank Stabilization

WHEREAS Resolution No. 2015-069 – March 15, 2015 approved Stantec Consulting Ltd. to provide engineering services for the Plum Creek Stabilization Project;

AND WHEREAS Stantec Consulting Ltd. has completed the tendering process for construction and tender was originally awarded on October 11, 2016 by Resolution No. 2016-011;

AND WHEREAS the original contract was not fulfilled;

THEREFORE BE IT RESOLVED that Council for the Municipality of Souris-Glenwood accept the recommendation of Stantec Consulting Ltd. to award the construction of the Plum Creek Bank Stabilization (Site #1) Project to Hodgson Construction Ltd. for the amount of \$990,368.11 (Excluding GST).

AND FURTHER BE IT RESOLVED all expenditures will be claimed through the Disaster Financial Assistance Program.

THEREFORE BE IT RESOLVED that Council for the Municipality of Souris-Glenwood accept the recommendation and that the Mayor and CAO sign the agreement with Hodgson Construction Ltd.
